*We are aware and we recognize that the purpose of a race is to race on the water according to the Racing Rules of Sailing (RRS) and the International Regulations for Preventing Collisions at Sea (IRPCAS) and other rules posted in the Notice of Race (and any amendments ), in the sailing instructions (and any changes) and all other official documents published by the Organising Committee. We are aware that the Regatta involves certain risks and dangers that may cause serious personal injury or death. We are also aware that the sport of sailing and related water activities contain hazards that can cause serious injury or death. We hereby grant you freely to assume and accept all known and unknown risks of injury and death resulting from the participation of the child in the regatta. We, on behalf of ourselves, our son (a) a minor, our representatives, heirs, administrators and assigns for ever accept to indemnify, defend and not to sue the Circolo della Vela Sicilia, the Yacht Club de Monaco the Yacht Club Costa Smeralda, its respective directors, the World Sailing, the Italian Sailing Federation, the Director of Race and the Sailing officers, members, agents, volunteers, or other sponsors ("indemnified parties") from all liabilities, losses, claims, demands and causes of each type of injury, death or property damage, and can be connected with the participation of my son (a) a minor or not to race resulting from actions or non-actions of the indemnified parties.*
