# NOTICE N° 2

## **UPDATED** COVID-19 PROCEDURES and RULES

#### PREAMBLE

This second amendment is released in light of new applicable laws published by the Italian Health Ministry. These laws shall be added to the previous ones and shall NOT replace them.

Travellers from any country in the EU or Schengen Zone can already use their national COVID vaccination certificates (e.g. Green Pass) in Italy as they would at home.

In the <u>Latest Ordinance</u> of July 29th, the Italian Health Ministry confirmed that COVID vaccination certificates (e.g. USA CDC white card) issued by health authorities in any of the following countries would also be accepted in Italy:

- Canada
- Israel
- Japan
- United States of America

**Quarantine** still applies to all people arriving in Italy from the UK – even if you're fully vaccinated or recovered, and including testing negative for COVID-19 within 48 hours before arriving in Italy, as all people departing from the UK are required to do.

Any visitor from countries not listed above even if fully vaccinated shall present a negative COVID-19 molecular test dated no later than 48 hrs prior to their arrival.

#### However:

1) the Article 5, Item 2, letter M of page 8 of the July 29th Decree (aka Latest Ordinance) states:

m) partecipazione da parte di atleti, tecnici, giudici e commissari di gara, rappresentanti della stampa estera e accompagnatori a competizioni sportive di livello agonistico, riconosciute di preminente interesse nazionale con provvedimento del Comitato olimpico nazionale italiano (CONI) e del Comitato italiano paralimpico (CIP) e regolate da specifico protocollo di sicurezza adottato dall'ente sportivo organizzatore dell'evento.

Participation by athletes, coaches and race officials, representatives of the foreign press, and supporting persons in sports competitions, recognized as being of pre-eminent national interest with a provision of the Italian National Olympic Committee (CONI) and the Italian Paralympic Committee (CIP) and regulated by specific safety protocol adopted by the sports organization organizing the event.

- 2) The <u>2021 Palermo Montecarlo</u> is an International Event approved by the Italian Sailing Federation (FIV) and posted on the 2021 Official Calendar;
- 3) The Organising Committee established a security protocol based on Italian Health Ministry Decrees as posted in the Notice n° 1 and the above additions.

#### **CHANGE TO NOTICE n°1**

Item 2.1 of NOTICE n°1 is changed to

 BEGINNING FROM THE DAY BEFORE THE START UNTIL THE DAY THE RACE STARTS, from 1700 of August 20 to 0930 of August 21 at Marina di Villa Igiea a team of doctors will test each crew, boat by boat.
